## **8. TERMS AND CONDITIONS**

1. All exhibitors must submit their photographs maximum one month before the event for the entry badges. No entry will be allowed without photograph. No new registration will be possible at the exhibition venue.
2. Only 3 representatives per booth (8/12 sqm) are allowed in the exhibition. This is applicable to both Partners and Exhibitors. No requests for additional entry will be entertained.
3. **One username and password will be allotted per company. A company may have a maximum of 2 usernames and passwords only if they have purchased 2 or more than 2 booths. This is applicable to both Partners and Exhibitors.**
4. **A State Government who is either a Partner State or a Theme State will get 2 username and passwords. In addition, the private sellers who are exhibiting through the Partner State will get a maximum of one username and password per company.**
5. Please submit 10 names of foreign buyers with their complete contact details for invitation as hosted buyer for GITB '12. These names must be submitted within 2 weeks of booking your booth.

Note: The foreign buyers will be invited to GITB '12 subject to approval of their names by the Foreign Buyer Committee for GITB and the availability of the hosted package at that time.

6. All exhibitors can collect their entry badges from April 13<sup>th</sup> from 10:00 a.m. to 5:00 p.m. onwards at the registration counter at B.M. Birla Convention Centre.
7. Please note that every Indian exhibitor will be given GITB '12 numbered stickers and will be required to put their signatures on the stickers and place it at the designated slot on the FTO B2B meeting card.

Note: All foreign buyers have to pay a refundable fee of 300USD before the start of the B2B meetings. This fee is refunded only when the foreign buyers complete their prescheduled meetings. Their B2B cards will be verified based on the signature and stamp put by the Indian sellers.

8. Every exhibitor has to complete the B2B meeting card for day 1 and day 2, collect the signature from the foreign buyer and submit it at the B2B meeting counters at the end of each day.
9. All exhibitors must collect your B2B meeting cards, GITB '12 numbered stickers and B2B schedule from the B2B counter at B.M Birla Convention Centre on April 16 and April 17 between 08:00 – 09:00 a.m.
